Component B: Integration of Information Systems and the NSDI Services Development that will cover the activities related to further digital transformation of RGA and advancement of Serbia's NSDI through ISREC's upgrade, development of new and upgrade of existing information systems and services including infrastructure cadaster, Digital Archive System, land consolidation and risk register, technical studies for further development and use of cadastral data such as 3D cadaster, expansion of GeoSrbija, development of mobile applications, IT supplies, support to cyber security and disaster recovery and technical support for data quality improvement.

Component C: Institutional Improvement, RGA Sustainability and Project Management which will cover the activities related to RGA's long-term institutional sustainability and project management for the Second Real Estate Management Project.
