The Republic of Serbia / Republic Geodetic Authority has received financing from the World Bank toward the cost of the Second Real Estate Management Project (REMP2), and intends to apply part of the proceeds toward payments under the contract for Procurement of the Cyber security system of the RGA.
2. The Republic Geodetic Authority now invites sealed Proposals from eligible Proposers for the development and implementation of an information system to support the RGA in carrying out its responsibilities in the land consolidation process, in particular: providing and delivering data, performing supervision and other activities within the RGA's mandate, and incorporating the results of land consolidation into the CISS (Cadastral Information System of Serbia). Qualification requirements include demonstrated experience in similar projects, ISO 27001:2022, ISO 9001:2015 and ISO 20000-1:2018 certifications, manufacturer authorization, and suitably qualified key experts, as further detailed in the RFP.
3. The procurement process will be conducted through international competitive procurement using Request for Proposals (RFP) as specified in the World Bank's "Procurement Regulations for IPF Borrowers", February 2025, ("Procurement Regulations"), and is open to all eligible Proposers as defined in the Procurement Regulations.
4. Bids will be evaluated in accordance with the evaluation process set out in the bidding documents. The following weightings shall apply for Rated Criteria (including technical and non-price factors): 40 %. This should comply with the mandatory requirements for Rated Criteria in the Procurement Regulations and for Bid cost: 60 %.
